# Video Gaming

On July 13, 2009, Governor Pat Quinn signed the Illinois Video Gaming Act making video gaming terminals legal in Illinois. The Act allows for video gaming terminals to be placed in certain liquor establishments, truck stops and fraternal/veteran's clubs throughout the state. The Illinois Gaming Board (the IGB or Board) has the responsibility of implementing and regulating video gaming in Illinois. Initially, the Board established several administrative rules and guidelines for all businesses that apply for the required gaming license. The rules provide guidance on matters including, but not limited to, standards, testing requirements, application procedures and violation hearings. The Village of Fox Lake approved the installation of video gaming machines within permissible establishments as allowed by the Video Gaming Act on June 12, 2012.

Since the passage of the Village's gaming ordinance, there are now 23 establishments that are licensed under the Act. From the beginning of operations by the first establishment approved in October 2012 to date, the Village has received approximately \$485,520 in gaming tax. The video gaming tax has provided the Village with a revenue source that is not directly imposed on residents and will help to balance the overall budget.



## Village Board Highlights

In an ongoing effort to provide open communication to the residents and business owners of Fox Lake, each edition of "The Anchor" will highlight actions taken by the Village Board during the time in-between newsletter editions. ## More Than Permits

The Community Development Department has been busy working on several projects aimed at improving the community. One of these projects is the creation of a Unified Development Ordinance (UDO). A UDO takes a comprehensive look at all of the adopted ordinances such as the zoning ordinance, sign ordinance and subdivision regulations and combines the ordinances into one cohesive document. It also allows the Village to incorporate many of its Comprehensive Development Plan guidelines into the UDO. Every section of the various ordinances is carefully reviewed to ensure they don't conflict with other ordinances, are easy to understand and help maintain certain characteristics of the Village while welcoming new development. The UDO project is estimated to be completed by 2017.

The Community Development Department is also in the beginning stages of designing a strategy that will revitalize the downtown area. At the direction of the Village Board, staff will be developing a Downtown Revitalization Plan to help increase foot traffic, incentivize new businesses and implement beautification projects that will enhance various areas of the downtown corridor.

## Did You Know...

## School's Open!

The Fox Lake Police Department would like to remind drivers that Fox Lake area schools are back in session. Please use caution when driving through the school zones. When approaching a marked school crossing zone between 7:00 a.m. and 4:00 p.m., on days when school is open and children are present, a driver must discontinue wireless/cell phone use, reduce speed to 20 mph, and stop and yield the right-of-way to any children or adults in the crosswalk area.



## Winter Vehicle Prep

The Fox Lake Motor Pool Department will be very busy in the next few months preparing the Village fleet for cold and snowy weather. # A Brief History Of The NWRWRF

In the late 1970's, pollution caused by failing septic systems surrounding the waters of Round Lake, Long Lake and the Chain-O-Lakes spurred the necessity for a regional wastewater treatment plant in the Northwest Lake County Area. The Northwest Regional Water Reclamation Facility (NWRWRF) went online in 1979. The original plant was designed to treat 6 million gallons of wastewater per day from the communities of Fox Lake, Round Lake, Round Lake Beach, Round Lake Park, Round Lake Heights, Hainesville, the Lakes Region Sanitary District and portions of unincorporated Lake County. In the late 1980's, it became apparent that the treatment plant and process needed to expand in order to meet the needs of a growing population. The first phase of construction began in 1991 and the second phase in 1992. The upgraded facility was designed to meet regulations established by the Illinois Environmental Protection Agency (IEPA) in the plant's National Pollutant Discharge Elimination System (NPDES) permit. These new regulations changed the manner in which the treatment plant operates. The newly redesigned treatment process consists of screw pumps that lift the wastewater through three stages, perforated screens, grit removal, primary clarifiers, conventional activated sludge aeration, clarification and disc filters in order to create primary sludge. The primary sludge that is pumped from the primary clarifiers into gravity thickeners are combined for digestion in three primary anaerobic digesters. A secondary digester holds the stabilized digested sludge prior to centrifuge dewatering. The de-watered biosolids are stored on site prior to land application. In 2006, the facility was awarded the prestigious Illinois Section Treatment Facility Operations Award from the Central States Water Environment Association. Expansion to 12 million gallons per day was completed in the fall of 2013 to handle increasing flow and was designed to address addition regulations including nutrient removal.



Residents are reminded that it is a violation of Village code to deposit leaves on Village streets. This type of yard waste can lead to clogged stormwater drains and inlets, thereby increasing the potential for street flooding. Please use yard waste bags for leaves and grass clippings.



Throughout this fall, the Sewer and Water Department will be conducting smoke testing in areas of the Village's sanitary sewer system. These tests are not harmful and will be done to identify unwanted sources of water. The Village will provide notification to specific areas affected before the testing begins.



Ghosts and goblins will be haunting Village streets this Halloween, Saturday, October 31.
