From the desk of the Mayor...



It's hard to believe that summer has come and gone. It seemed like the lakes were closed more than they were open this summer. The predictions are for increased rainfalls for the next several years. I have been appointed to the Fox River Flood Commission as the Lake County Municipal Representative. We will be collecting and analyzing data and working with IDNR to minimize the impact of the flooding on our community. One neighborhood, Knollwood Subdivision, was particularly impacted. Mail delivery and garbage pick-up were interrupted for up to two weeks at a time. The Village, along with Stormwater Management of Lake County will work to remedy this situation.

The increased rainfall and prolonged flooding had a negative impact on our local economy. Several of the marinas and restaurants told me that this was a very challenging time. When the lakes are closed, people are not visiting our area, patronizing our restaurants, marinas, gas stations and resorts. In turn, the Village sales tax revenues also decline.

Another priority for the Village is going to be repairing our local streets. In the past two years, we have repaired Sayton Road, the frontage road at Jewel and Menards and Grand Avenue. Next year, Nippersink Road will be repaired, along with as many other streets as we can. Staff was able to have the IDOT designation of several roads changed in order to become eligible for funding. Our staff has obtained over seven million dollars in grants in the past six years, and this is how we are able to do the work we have done. We will continue to seek all available funding.

We have conducted the street analysis, which can be viewed on our website at the transparency portal, in the infrastructure tab, <https://www.foxlake.org/DocumentCenter/View/4193/Roadway-Inventory-Report---2019>. Appendix C: Roadway Inventory – Street List, by Condition Rating has the ratings of all Village roads in Fox Lake.



ANCHOR AWARD

HONORING THOSE THAT SERVE THE COMMUNITY OF FOX LAKE

Fox Lake-Grant Township Area Historical Society

The Anchor Award is a quarterly award presented to a local group or organization within our community. Organizations that receive the award will be presented with a plaque at a Village of Fox Lake Board Meeting and an article published in the Village Newsletter about the organization. Please contact Mayor Schmit at schmidt@foxlake.org if you know of an organization within Fox Lake that should receive this award. This quarter's Anchor Award goes to the Fox Lake-Grant Township Area Historical Society winners for their enrichment of Fox Lake Histor.

The Fox Lake-Grant Township area has a rich history, particularly during the great Resort Era. Tales of this history have been largely passed on by word-of-mouth, folklore and rumors. Resorts, gambling, Lotus Beds, ice harvesting, Capone, Guinness Book of Records and boats are examples of popular topics of discussion. The Historical Society was formed in 1997 for the purpose of capturing, preserving, and presenting this history for our residents. This has led to the Society becoming an important resource for differentiating historic facts from fiction.

There are 8 rooms of historical displays in the Grant Hall Museum, including a library with over 100 binders and books with historic photos and articles. Yearbooks from the local schools provide visitors with opportunities to reminisce about their earlier years – or in many cases, their parents or grandparents. The Museum is located on Washington Street in the old Ingleside business district. Many visitors are surprised by the amount of material available.


The Historical Society has developed and conducted many programs for the public, including the Powerpoint series of presentations on the area's history. The most popular of these have been Fox Lake Region Hotels & Resorts, History of Fox Lake, Holiday Park, Entertainment Places of Fox Lake and the History of the Mineola. Presentations have been conducted at the Museum, the Fox Lake Library, neighboring historical societies, senior facilities and schools. Special Museum tours and customized programs have been created for various organizations such as church groups, Boy Scouts and schools. In recent years, the Society has increased its school partnering activities.

Area residents are encouraged to consider becoming Historical Society members. While it provides an opportunity to support a great local organization, it also provides the opportunity to learn more about the rich history of the community we live in. One does not have to be knowledgeable with local history to join. In fact, some join just for the opportunity to learn more about the history. The meetings and programs have proven to be very informative.

The Museum is open on the 1st and 3rd Sundays of the month from 1 PM till 4 PM, as well as on other announced special occasions. Customized tours and special programs have been conducted for church groups, homeowners groups, school groups and even families.

The Fox Lake-Grant Township Area Historical Society was organized as a not-for-profit corporation in 1997. In 2003 the Society acquired the century-old, former Grant Township Hall. This gave the Society a real home, while the building was named "Grant Hall Museum". Going forward, the Society had a permanent place to store its artifacts, photos, documents and records. Thanks to the members, volunteers and donors the Museum has evolved into a significant resource for the entire local community.

The Historical Society does not receive any direct funding from the Village, the Township, nor any other governmental agency. This all-volunteer organization relies on membership dues, donations and fundraisers to sustain its existence.

WINTER REMINDERS

With winter fast approaching, the Public Works Department has some reminders and information to share.

From the Street Division

- The Street Division is responsible for removing snow from approximately 60 miles of streets, eight Metra parking lots, six Village parking lots, and numerous sidewalks.
- As a reminder, Route 12 and Route 59 belong to and are maintained by the Illinois Department of Transportation (IDOT).
- Rollins Road is maintained by the Lake County Division of Transportation. Wilmot Road is maintained by the McHenry County Division of Transportation.
- Village Ordinance requires no parking on Village streets within a two inch or more snowfall and until snow plowing operations are completed. This includes not only the initial pass of a snow plow, but also returning to widen the full width of the street.
- After an accumulation of snow, the Street Division will display temporary “No Parking for Street Cleaning” signs. These are yellow with black lettering. **Vehicles not in compliance will be towed.**
- Please refrain from allowing children to play in snow piles alongside the road.

From the Water & Sewer Division

The Public Works Department - Water Division is responsible for maintaining over 47 miles of watermain throughout the Village. Here are several reminders and tips to keep your pipes from breaking this winter:

- We are asking Residents to “adopt” their hydrant and keep the area around them free of snow. Having a hydrant clear and visible will help the Fire Department and the Water & Sewer Division in case of emergencies.
- When temperatures are severely cold, run the cold water faucet at a minimal rate.
- In extremely cold weather, leave cabinet doors under sinks open.
- Locate your home’s main valve so you can shut off the water temporarily if a line does break.

If your pipes do freeze:

- Use a hair dryer set on low, heat lamp, or light bulb to gradually warm and thaw the frozen pipe.
- Too much heat in one spot, can burst the pipe, so be sure to evenly distribute the heat over a large area.

INTERNET SAFETY ZONE

Internet purchase exchange locations are now a thing in Fox Lake. Internet buyers and sellers who don't want to give strangers online their address can now exchange goods in a safe environment.

With the increasing popularity of internet-based purchases from websites such as Craigslist, eBay, Facebook, and OfferUp, the Fox Lake Police Department has decided to offer the use of the lobby area to conduct such exchanges in person. The area is video and audio recorded for your protection.

The Fox Lake Police Department encourages residents or anyone who participates in these types of transactions in the area to take advantage of this location. Please don't meet strangers at private residences or in areas that you are unfamiliar with. No appointment is necessary. When you come into the lobby through the main entrance of the building, you can let the front office member or dispatch know why you are there by pressing the button by the entrance door.

The Fox Lake Police Department highly recommends citizens:

- Ask as many questions as possible before purchasing any product. If the seller can't answer questions, there is a strong probability the seller does not actually have the product and could be "setting up" the potential buyer.
- Do not buy from sellers who only list an email address. This could be a "red flag" that the seller has something to hide.
- Meet in a public place. Criminals do not want witnesses and they are often seeking easy targets.
- Do not go alone. If you are selling or buying items, consider having a friend or family member accompany you.
- Never go to a second location. If you arrive to the predetermined meeting location and are asked to go to another place, this should raise serious "red flags."
- Trust your instincts. If it sounds too good to be true, you're probably right.
- Stay in communication. Let your spouse, friends, family or coworkers know where you are going, who you are meeting with and when you will be back.
- Be on guard and smart. Don't wear expensive and "flashy" clothing, (jewelry or show large amounts of cash). Doing so, can invite criminal activity.



The Fox Lake Police Department will not be a witness or arbiter during any of the transactions. Transactions involving weapons, hazardous materials, illegal drugs, or stolen property are prohibited.

FLPD members will not be necessary unless there is an emergency or violation of the law. The lobby will be available for these transactions from 8:00 a.m. - 10:00 p.m. 7 days a week.

This initiative aligns with part of our mission "to ensure a safe and secure place to live, work, and visit."

THE 2020 CENSUS AT A GLANCE

CENSUS DAY IS APRIL 1, 2020

The Village of Fox Lake is reminding everyone that the 2020 Census is just around the corner!

The U.S. Census Bureau is the federal government's largest statistical agency. The Bureau is dedicated to providing current facts and figures about America's people, places, and economy. Federal law protects the confidentiality of all individual responses the Census Bureau collects.

The U.S. Constitution requires that each decade a count is taken — or a census—of America's population. The census provides vital information for the Fox Lake community:

- Census data determines how many representatives each state gets in Congress and is used to redraw district boundaries.
- Communities such as Fox Lake rely on census statistics to plan for a variety of resident needs including new roads, schools, and emergency services.
- Businesses use census data to determine where to open places to shop.
- Each year, the federal government distributes more than \$675 billion to states and communities based on Census Bureau data. Some of these items include funds dispersed to states for federal programs, Medicare/Medicaid, SNAP, Section 8 Housing Vouchers, Title 1 Grants, Infrastructure/Road Grants, Headstart, Free and Reduced Lunch, and more.

In 2020, the Census Bureau will implement new technology to make it easier than ever to respond to the census. For the first time, you will be able to respond online, by phone, as well as by mail. By responding online, by phone, or by mail, a Census employee will not visit your home.


Your information is protected by law. The law requires the Census Bureau to keep your information confidential and use your responses only to produce statistics.

The Census Bureau cannot publicly release responses in any way that could identify you. The Census Bureau will never share information with immigration enforcement agencies such as ICE, law enforcement agencies such as the FBI or police, or allow it to be used to determine your eligibility for government benefits.

The Village of Fox Lake established a Complete Count Committee with Schools, Faith-Based Organizations, the Library, community members, and more to ensure Fox Lake is properly counted. By establishing this committee, the Village hopes to continue to spread the importance of the 2020 Census.

CENSUS 101: WHAT YOU NEED TO KNOW

The 2020 Census is closer than you think!

Here's a quick refresher of what it is and why it's essential that everyone is counted.

Everyone counts.

The census counts every person living in the U.S. once, only once, and in the right place.




It's in the constitution.


The U.S. Constitution mandates that everyone in the country be counted every 10 years. The first census was in 1790.

It's about fair representation.

Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.



It's about \$675 billion.



The distribution of more than \$675 billion in federal funds, grants and support to states, counties and communities are based on census data.

That money is spent on schools, hospitals, roads, public works and other vital programs.




It's about redistricting.

After each decade's census, state officials redraw the boundaries of the congressional and state legislative districts in their states to account for population shifts.

Taking part is your civic duty.

Completing the census is mandatory: it's a way to participate in our democracy and say "I COUNT!"

Signage

- The Village places event signage on three Village of Fox Lake owned signs. They are located by Jewel off Frontage, in front of the High School, and at State Park Road. Additionally, the Village has two marquee signs – one by the train station and another by the Fox Lake Police Station.
