The Lakefront Park expansion is nearing completion, with a project of this magnitude, construction will occur throughout the summer. An area once referred to as "Skid Row," will now be a place to bring your family. Upon completion, our residents and future generations will have a place to enjoy the splendor of our town.

This expansion is only possible because of the arduous work of your Village Board and the dedicated Village Staff. The duty of the board and staff is to provide essential services to our residents. Those basic services include Public Safety, Streets, Sewer & Water, Parks & Recreation, Code Enforcement, and Building & Development. To provide these vital services, the Village has over 100 employees. I want to give credit to all our employees, and the strength of our community, and additionally to take this opportunity to share with you our Executive Staff and Department Heads. They are truly an amazing group of dedicated, talented people.

Jessica Chernich is our Village Administrator. Jess has a master's degree in public administration, a Society for Human Resources Management Certified Professional, and several years of municipal administration experience. In addition to overseeing the day-to-day operation of the Village, she is the liaison between the employees and the Village Board. The board creates policies and Jessica conducts those policies.

Ashley Magnine is the Assistant to the Administrator. Ashley is a true success story. She started as an Administrative Assistant, working at the front desk.

She has advanced from Administrative Assistant to Deputy Clerk; while continuing her role as the Deputy Clerk she is working toward her Registered Municipal Clerk (RMC) and Society of Human Resources Management Certified Professional (SHRM-CP) certifications and is now the Assistant to the Administrator and Human Resources Director. With the help of Sunni Butler, Administration Management Analyst, who assists the administration department with a multitude of tasks including research projects, managing data, grants, and communications.

Dawn Deservi is the Chief of Police of Fox Lake. Dawn started as a patrol officer and firefighter. Dawn has had a remarkable career. Through sheer dedication, she advanced from patrolman to sergeant, Lieutenant, Commander, and Assistant Police Chief and is now our Police Chief. Dawn is now one of the most respected law officers in Northern Illinois and we are fortunate to have her serving our community.

Lindsay Szafran is our 9-1-1 Director. Lindsay oversees the award-winning FoxComm service in Fox Lake that serves several communities. When you have an emergency and dial 911, Lindsay makes sure your call is answered and directed to those who will provide you with police, fire, and medical services the emergency necessitates. Lindsay is also in charge of the Fox Lake participation in the county-wide 911 consolidation, which will reap many benefits for the community.

Mary Locher is our Finance Director and Treasurer. Mary is a Certified Public Accountant with a wealth of experience in the private and municipal sectors. Along with Laura Rudkin, Accounting Manager, and the longest-tenured administration employee, and Lorena Martinez, Utility Billing and Payroll Clerk, Mary manages the finances of the Village and completes all the state-mandated reports and audits. Mary is also involved in obtaining and administering grants.

Jodi Luka is our Community & Economic Development Director. Jodi has a master's degree in public administration and policy. Jodi's main duty is to attract development to Fox Lake. This increases revenues so the Village can provide more essential services, without increases in permits and fees. With assistance from Brigitte Weber, Neighborhood Services Manager, Jodi, and her staff work to carry out Code Enforcement, Plan Review, and conduct the Planning & Zoning Board meetings.

Susan Novak is our Public Works Director. Susan is a Professional Engineer, Certified Floodplain Manager, and Enforcement Officer. Susan also has vast experience in both the municipal and private sectors. With Tom Muehlfelder, Streets Supervisor, they manage the 55 miles of Village streets and sidewalks and assist in maintaining the many buildings and parks in town. With Trent Turner, Sewer & Water Supervisor, she maintains over 100 miles of sewer and water pipes, 5 water tanks, and over 25 lift stations. Susan also administers several grants.

John (JT) Thompson is the Executive Director of the Northwest Regional Water Reclamation Facility on Rollins Road. JT has been with the Village for over 31 years. On average, the plant treats 9 million gallons of wastewater daily and ensures all Environmental Protection Agency and discharge permit regulations are followed and reported. During flood conditions, the plant runs 24 hours a day and treats up to 30 million gallons of wastewater daily. He is another truly dedicated staff member.

Finally, **Jennifer Kuhn** is the Program & Events Manager of Parks & Recreation. Jennifer runs our Parks & Recreation Department. In addition to the summer concerts,

all the events, parades, and other activities, Jennifer and TJ have a total of nine parks in town to maintain. They do an excellent job. When you see them at an event or the park, say hello and let them know what a wonderful job they are doing.

As you can see, we have a talented staff. It takes more than talent to be successful. Working together to achieve a goal is the strength of this staff. The leadership each department head shows is evident in their results, and I could not be happier with our staff.

Enjoy the summer and our improved Lakefront Park and say hello to one of our many events

this summer. We can hardly wait to see you there!




PUBLIC WORKS DEPARTMENT

SUMMER IS RIGHT AROUND THE CORNER

Brush pick-up resumed in early April and will continue on Fridays until the fall. However, due to other work, holidays, and inclement weather, pickups may be delayed. As a reminder, branches must be trimmed by the homeowner, not a tree service. We ask that limbs are no longer than 6 feet in length, no larger than 6 inches in diameter, and neatly stacked at

the curbed, not piled into a messy heap. Piles are not to exceed 4'x6'. Yard waste, tree trunks, logs, weeds, and dirt do not qualify as brush. Piles not meeting these guidelines will not be picked up.

HYDRANT FLUSHING

New this summer, the Fox Lake Sewer & Water Department will be flushing fire hydrants in our South water system. Typically, this is completed in the Spring and Fall. We are excited to share that the Village will be adding a third flush this year for water quality purposes and ensuring your water quality is the best it can be. Additionally, this process will make certain hydrants are in good working order in case of emergencies, and to help flush sediment out of the distribution system.

Signs will be posted in each area before the flushing begins. Flushing will take place between the hours of 7:30 a.m. and 3:00 p.m. - Monday through Friday.

It is not recommended to do laundry on the days hydrants are being flushed in your area. Flushing stirs up iron sediment which can discolor your laundry. After flushing in your area, if there is any discoloration in your faucet water, allow the cold water to run for a few minutes, preferably from a tub spout or outside spigot. Bypass any softeners and/or whole-house filters and avoid using hot water until the water has cleared.

WAYFINDING SIGNAGE

Over the last few years, the Village has been working on evaluating signage needs, and improvements. With input from the public, we unveiled a new branding style in 2019. Since then, the Village has been working on budgeting and permitting to implement the new signage throughout town, this includes new wayfinding signage, monument signage, banner signage, pedestrian signage, and entryway signage. Recently, the Village went

out to public bid to start the first phase of the signage installation. This will include over 20 new signs throughout the Village, including new Welcome to Fox Lake entryway signs, and a monument sign at the corner of US-12 and Grand Avenue. The new signage is highly anticipated and will help branding efforts with the Village as well as help those new to the area navigate throughout Fox Lake.

IMPORTANT INFORMATION FROM YOUR POLICE DEPARTMENT

During the spring and summer months, neighborhoods throughout the State of Illinois historically experience an elevated number of thefts from vehicles. While committing these thefts, the criminals typically target unlocked vehicles where valuables are visible through the windows. These individuals generally rely on their ability to move quickly without raising any suspicion. By searching for unlocked vehicles, they don't create any excessive noise, such as breaking glass, that would attract attention from anyone nearby.

Statistics show that vehicle burglaries typically occur during overnight hours, however we do encounter cases that have been during daylight hours. To keep your property safe and deter criminal activity in our community, we encourage residents to take action and follow preventative measures (listed below).

Camera monitoring systems have proven to be extremely valuable. They not only serve as a deterrent for criminal activity; they also provide excellent evidence that can assist in an investigation. If you have chosen to install a camera system at your place of business or residence, it is important to periodically check the system to ensure it is operating correctly and still recording. It is recommended to keep the video for at least 30 days. The Fox Lake Police Department reminds all residents to report any suspicious behavior to the police (847-587-3100) and to report any incident where they believe someone has entered their vehicle without permission.



-  Always lock your vehicles

IL RT 59 AT GRAND INTERSECTION IMPROVEMENT

New and ongoing construction continues at the Washington and IL 59 intersection. The anticipated improvements are listed below:

- Reconstruction of the IL 59 & Grand Ave. intersection is to include left turn lanes for IL 59 and EB Grand Ave
- Right turn lane for SB IL 59
- An updated traffic intersection signal
- Realignment of Washington St to meet IL 59 South of Grand Ave.
- New signalized intersection on IL 59 at realigned Washington St Connection to Grant Community High School
- Additional left turn lanes for entrances along IL 59 and Grand Ave.
- Additional sidewalks and multi-use paths
- Drainage improvements

NWRWRF TREATMENT PLAN

ONLY YOU CAN PREVENT POO-LUTION

Phosphorus (P) is one of the most important nutrients in agricultural systems when used and applied properly. In natural environments or properly tested quantities, phosphorus is a valuable nutrient and fertilizer that promotes plant growth and development. However, in excess, phosphorus can create problems in our waterways and drinking water called eutrophication. When phosphorus pollution (runoff) enters our lakes, rivers, and streams, it causes green scum and harmful algae blooms that can deplete waterways of oxygen, cause fish kills, damage ecosystems or even result in “dead zones” in larger bodies of water.

Our homes — via yards, driveways, appliances, and pets — contribute to nutrient pollution. Fortunately, there are many strategies that individuals can use to help reduce phosphorus runoff. Here are a few simple ways to reduce phosphorus pollution in local lakes, rivers, streams, and watersheds.



OFF THE STREETS

Keep leaves, grass clippings, and other organic matter off the streets. Avoid blowing leaves or clippings into areas where they can wash into storm sewers. Once in the water, phosphorus from clippings and leaves can grow algae. Blow or bag your leaves, keep your clippings on the grass, and use other organic matter as fertilizer.



LOW P FERTILIZERS

Use non-phosphorus or low-phosphorus fertilizer on lawns and gardens to avoid over-fertilizing. Look for package formulas of nitrate-phosphorus-potassium with a middle number (which represents phosphorus) of zero. For example, 22-0-15 indicates no phosphorus. Lower phosphorus fertilizers are also an option; look for numbers like 13-2-13 or 20-3-19.



ROOTS THAT GO DEEP

Plant buffers of deep-rooted plants in landscaping and along shoreline properties. Natural plantings or plants with deep roots do a better job of absorbing and filtering runoff during rain events and can provide habitat for wildlife.



CONTROL PET POO-LLUTION

Pick up pet waste from yards, parks, and shorelines whenever possible. Pet waste contains phosphorus (and other nutrients and bacteria) that can pollute water when it rains and create runoff poo-llution when it is not disposed of properly.



DRAIN SMART

Direct downspouts to lawns and plant beds and use landscaping practices that stop or slow runoff from your property. By aiming your downspouts into landscapes, versus hard surfaces like sidewalks and driveways, you can reduce runoff to storm drains. Water will be better able to soak into the ground.



WATCH YOUR SOAPS

Use low- or no-phosphate cleaning products. Some soaps, detergents and household cleaners contain a form of phosphorus called phosphates. Choosing phosphate-free products can help minimize pollution.

UPCOMING CHANGES

for Refuse and Recycling Services

The Village of Fox Lake's Waste Management contract is due to expire in October of this year. The Village is actively seeking proposals for review to make a fiscally responsible decision for our residents and community. Current rates for single-family and multifamily units are:

- Single-family: \$18.90 (\$37.80 per billing)
- Multifamily: \$18.56 (\$37.12 per billing)

It is anticipated an increase of up to 7% per unit price may go into effect with a new contract to cover economic inflation and other affiliated factors including increased fuel costs. We, at the Village, want to be transparent and upfront with our residents about this upcoming change so you can better prepare for the financial impact it may have on your homes, lives, and budget. Rest assured that the Village will be making its best effort to obtain the most cost-effective, reliable services on your behalf.
