### FROM THE DESK OF THE MAYOR DONNY SCHMIT

As Summer comes to an end, we await the changing of the season, the excitement of Friday night football at the local high school, and the array of autumn events that the Village of Fox Lake and Grant Township offer to our community.

I am proud that five generations of my family have called Fox Lake home since we moved here in 1957. Over the course of my lifetime, I have seen many changes in our town. I watched Dollar Lake become the plaza in our downtown. I saw a gravel pit at routes 12 & 134 become Dominic's shopping center. A gravel pit at the entrance to the Chain O' Lakes State Park entrance is now a subdivision called Vern's Landing. Vacation Village was a cornfield on State Park Road when I was young. My childhood was spent in "Snake Woods" off Grass Lake Road, where I rode my horse and played in what is now the Woodland Green and Leisure Village subdivisions. And it was at Holiday Park, now another subdivision, where I worked as a lifeguard and met my future wife during my teenage years.

Things and ways of life change. One thing that has not changed since I was young is the support of our youth and the spirit of our town. Just as when I grew up, there is an army of volunteers that run our youth sports programs, and they are very much appreciated.

When I was a young boy, there was always something to do. Like my own upbringing, a dedicated group of volunteers continues to manage our youth sports programs, and their efforts are greatly valued. Growing up, there was never a dull moment. Vacant fields and empty lots became impromptu baseball and football fields. Local hangouts like Deer Haven near the police station, the mini-golf and batting cages along Route 12, bowling alleys, the cinema, and Holiday Park were the hotspots of our youth. Deer Haven by the police department, mini golf and batting cages on Route 12, the bowling alleys, movie theater and Holiday Park kept us busy in our preteen and teenage years.

I have seen our town go through hard times and times of prosperity. As video games and television became

more prevalent, one by one, the activities and places I enjoyed as a youth went away. Vacant lots and fields became housing. Deer Haven and the batting cages and mini golf were not economically feasible and closed. The bowling alleys and movie theater also closed. Our town is back on the road to prosperity. Our Community Development Department is diligently working to attract more businesses to the Village. The state-of-the-art movie theater has recently undergone expansion. Additionally, our library now offers an expanded array of programs and resources for all age groups.

The Village Board and staff have heeded your requests and suggestions, striving to offer activities for both youth and adults. Following your suggestions, for the Lakefront Park expansion, we transformed an area once known as "Skid Row" into a family-friendly zone for enjoyment and socializing. Our Parks and Recreation Department offers numerous programs for all age groups.

We had a decision to make on Lakefront Park expansion. Due to various factors, the construction of the beach, outdoor pickleball court, and splash pad could not be finalized this summer. Consequently, we faced a choice: either keep the park closed until all amenities were complete or open them progressively as each was constructed.

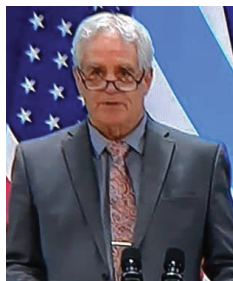

The shoreline has established itself as a beloved fishing destination. 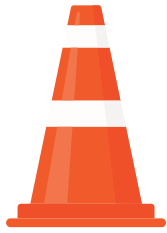

## WATER SERVICES & BUFFALO BOXES



The Sewer & Water Department has been working on updating and locating buffalo boxes for the GIS mapping program. During this effort, we have noticed there are multiple

properties where buffalo boxes are located in paved, hard surface driveways or private walks.

If a buffalo box in one of these locations is damaged by the building owner or user, then the buffalo box shall be repaired by the Village at the owner's expense. The restoration of the area will be the responsibility of the property owner, and an indemnification agreement will be required for the property.

# MAILBOX REPAIR OR REPLACEMENT POLICY FOR THE SNOW SEASON

The Village policy covers mailboxes only if they are physically struck by a snowplow. Before winter, drivers conduct dry runs to determine the safest locations to deposit snow off the roads, minimizing damage from snow ejected by the plows. A certain velocity is required to effectively throw snow, and drivers exercise their best judgment depending on the snow type. If you suspect your mailbox was damaged during snow removal, report it to the Village within 48 hours for assessment. Non-repairable mailboxes that were directly hit will have temporary replacements installed.

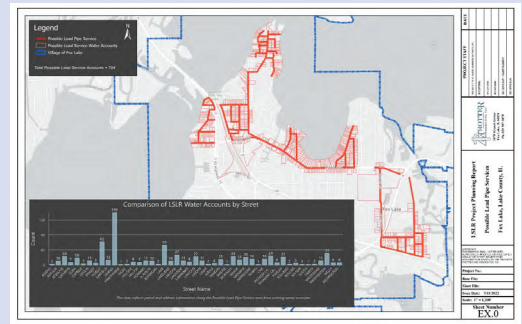
Subsequently, the property owner is presented with two options:

- The department will replace the mailbox with a standard post and box when conditions/weather permits.
- The Village will reimburse up to \$150, upon receipt, toward the property owner making the repair or replacing the mailbox.

## WHAT IS THE MAILBOX REPAIR POLICY?

It is a policy of the Village of Fox Lake that all mailboxes damaged by the Public Works Department during snow and ice operations will be replaced by a standard post and box when conditions permit. The Village will only take responsibility for the damage if it is caused by a direct hit from the snowplow. If damage occurs as a result of the snow being discharged from the plow, the responsibility for the repair and/or replacement falls on the property owner.

The Village of Fox Lake will not be responsible for the full replacement cost of mailboxes including custom mailboxes. The Village, however, will reimburse up to \$150.00 to the property owner toward the replacement cost of a mailbox of their choice. In instances where property owners have specific mailbox guidelines set forth by homeowners' associations, the responsibility for the cost difference above and beyond \$150.00 will be between the property owner and the association. At the Village's discretion, this replacement fee will be revised and adjusted as needed.



# LEAD SERVICE LINE REPLACEMENT PROGRAM

The Village of Fox Lake is commencing its Lead Service Line Replacement Program with Five Star Energy Services, the lowest responsible bidder for the project. The Village has obtained about \$2.28 million of principal forgiveness from the IEPA for this initiative.

The Fox Lake water system serves both residential and non-residential customers, with the majority of non-residential demands located south of Nippersink Lake. The system encompasses approximately 50 miles of water main, 701 fire hydrants, and 625 mainline water valves. The section of the distribution system south of Nippersink Lake, which accounts for two-thirds of the overall system, consists of roughly 30 miles of water main, with the oldest sections dating back to the 1920s.

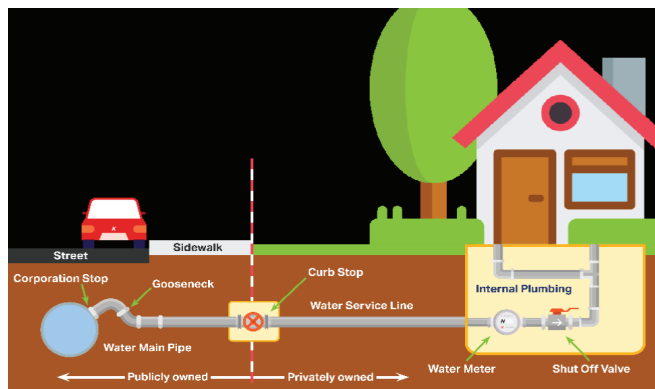
The typical ownership of the water service line is illustrated in the image on page 6 and is defined as follows:

- Village-owned water service (Public Side): Extending from the water main to the curb stop.
- Property-owned water service (Private Side): Stretching from the curb stop to the water meter inside the building.

As the Village continues to inventory water service line materials within its water system, the inventory will identify:

- The total number of service lines in the current year's community water supply (CWS).
- The material composition of EACH service line connected to the community's distribution system.
- The overall service material composition
- The count of suspected lead service lines identified since the last material inventory submission.
- The number of suspected or known lead service lines replaced since the last material inventory submission.

While a complete and verified inventory is currently being compiled, the Village is prioritizing the services installed with the original South System, which are within the oldest sections of the distribution system.



The replacement of lead service lines and related site work will be confined to properties that are presently utilizing lead water service lines. The expected environmental impacts include construction noise, dust, traffic, and soil disturbance. These impacts, while minor and transient, will be minimized through the implementation of best management practices throughout the construction phase. There will be continuous communication with residents and nearby businesses affected by the project. Due to limited access and narrow streets, temporary road closures and detours are anticipated as construction advances.
