At the regular Board Meeting, held in said Village and County in the State of Illinois at 6:30 p.m. on April 25, 2017 meeting was called to order by Mayor Schmit. The following official business was transacted:

V. Committee of the Whole

A. Finance

Trustee Stochl asked if there were any questions regarding the warrant list. There were none. Trustee Stochl asked the Board if they had any questions regarding the Annual Budget FY 2017-2018. There were none. Trustee Stochl stated that he would be asking for a motion regarding Antique Motor Vehicles stickers. He asked if there were any questions. There were none.

Trustee Stochl stated that he would be asking a motion regarding an Amendment to the Ray Chevrolet Economic Incentive Agreement. He asked if there were any questions.

Trustee Marr asked if the Thousand Dollar fee (\$1,000) fee is not a maximum but a flat fee. Mayor Schmit stated that this is a recommendation from staff and was not discussed with Ray and he had spoken with Finance director Stephanie Hannon, that we would cover cost of the placards on this. Trustee Marr asked if this fee was going to be included in the motion or is it going to be discarded before it gets there. Mayor stated that he was not sure both as it is a recommendation from Staff to cover the cost of the placards and he is not sure how much that is. Mayor stated that the fee recommended is to cover the cost of the material and administration fees. Mayor stated that it is up to the Board to add this item to the motion. There was discussion amongst the Board regarding recommendations from Staff and requests from business owners.

Trustee Marr stated regarding he sidewalk and that it is one of his pet projects. Trustee Marr stated that this agreement is amending an agreement for a special use from 2014 regarding sidewalks on the

west side of the property. This is three years and the sidewalks are not there. Trustee Marr stated that does not want to see three years later the sidewalks not being on the east side. He noted that he is not trying to be hard on Ray Chevy and he respects them. However, he is just trying to get what the Village deserves out of this and he would like to encourage them to begin the permit process with IDOT as that takes a while to acquire and if they do this along with the construction, that move the process along at the same pace.

Mayor Schmit stated that Senator Altoff has set up a meeting with IDOT and himself on Thursday and he has a list of items he would like shovel ready. These are the bike path over Route 12 and a stop light that is in our comprehensive plan at Jake Frost Lane. Mayor stated that he has spoken with Ray regarding his sidewalks and he is also responsible for a crosswalk that they have to talk to IDOT about. Attorney Teegen stated that the original agreement states that he has one- year after the occupancy permit is issued to complete the sidewalks. Trustee Marr stated that he understands that but the Ordinance also reads "pending permits from IDOT" which take a while to get. Trustee Marr stated that he would like them to start obtain these sooner than later to be on schedule and not be delayed by that process. The Board agreed that the fee should be a part of the motion and leave it to them to vote in view of that.

B. Building and Zoning

Trustee Marr stated that the Board has a Façade Improvement request from Joseph Tenuta, owner of Sports Physical Therapists of Fox Lake for the amount of 4,000.00. There was discussion from the Board that there needs to be a check list when businesses come into the Building Department for Permits. This will then allow the owners to know what programs are offered from the Village and hopefully they will not miss out on opportunities such as the Façade Improvement Program.

C. Parks and Recreation

Trustee Koske then went through the following events and programs in the Village. All events and programs can be found on the Village website at foxlake.org.

- May 13th- High School Fishing Tournament, Launch at the American Legion, Weigh-in at the Lakefront Park.
- May 13th- Teen paint night at Studio 25 Art Creations.
 - Join us at Studio 25 Art Creations in Fox Lake every 2nd Saturday throughout the summer (May-August) from 7pm-9:30pm for teen paint night! This program is a fun way to spend a Saturday evening hanging out with friends while learning to paint cool works of art with instruction from Studio 25 staff. Cost \$30.
- May 18th- Senior Luncheon at the VFLVFD Bingo Hall.
- May 24th- Marriott Theatre (Lincolnshire) Bus trip to see "She Loves Me." Fee includes, show, transportation, and lunch.
- June 4th Triathlon- Race Starts at 7am, preparations continue.
- This year is Fox Lake's 110th Anniversary and the Village will be tying the celebration in with all events for the year.
- Lakefront Park Update: work continues on the siding and dry wall has begun to be installed.
- The National Honor Society Community Garden Day was a huge success. We had over 40 volunteers from Grant High school in attendance. Tasks included laying cardboard to block

weeds, laying mulch, building new garden beds, filling new garden beds with soil and compost and staining the garden fence. At the conclusion of the event some of the high schoolers sat in the trustee and mayor seats while the Mayor explained many of the decisions and tasks the village board is responsible for. The mayor also had the students who were sitting the trustee seats vote on a couple mock issues to show how sometimes making decisions can be challenging. This was overall a fantastic day with a great group of volunteers. We hope to work with this group many times in the future.

- Work continues on NRPA "Meet me at the Park" \$20K grant for a local park. We have been getting a good amount of hits on social media with many community members posting that they have voted. It is nice to see an outpouring of support from the community on this endeavor.

G. Streets

Motor Pool supervisor, Luke Catullo stated that this was a detective car and sat idle while in use. Trustee Stochl stated that if that is the case, and he knows Luke is not the one purchasing the vehicles, but they should look at cars that have better efficiencies while sitting idle. There were no audience comments this evening.

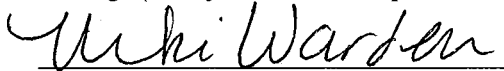
XII. Adjournment
