

# VILLAGE OF FOX LAKE VILLAGE BOARD MEETING MINUTES

STATE OF ILLINOIS,
Lake and McHenry Counties,

Village of Fox Lake

At the regular Board Meeting, held in said Village and County in the State of Illinois at 6:30 p.m. on November 12th, 2019 meeting was called to order by Mayor Schmit. The following official business was transacted:

#### 1. Call to Order

#### **Roll Call**

Present Mayor Schmit; Village Attorney Caryn Barone; Trustees: Jensen, Stochl, Konwent, Marr, Moore and Koske.

Staff also in attendance: Anne Marrin, Laura Linehan, Kealan Noonan, Jimmy Lee, Jr., Ryan Kelly, Phillip Love and Donovan Day.

#### 2. Approval of Minutes

Trustee Marr made a motion to approve the Village Board Meeting Minutes for October 22, 2019 as presented, seconded by Trustee Konwent. All were in favor. Motion Carried

#### 3. Approval of the Warrant

Trustee Marr made a motion to approve the Expenditures/Warrants/ Transfers for November 12, 2019 in the amount of \$1,278,892.34, Seconded by Trustee Koske.

Anne Marrin reminded the Board there were three weeks between the meetings which is why the warrant is higher. In addition, a batch went out for all contractual agreements; the first payment was made to Joel Kennedy Construction for the Interconnect project for \$348K and a payment was made for the Sewer Lining project for \$122K.

## 4. Special Business (Appointments, Swearing In Ceremonies, Proclamations)

There will be a motion this evening to reappoint Fred Loffredo and Walter Kubalanza to the Police Pension Board. If this motion is passed, they will be sworn in at the next Village Board Meeting.

#### 5. Village President's Report

The owners of the Plaza contacted Mayor Schmit about their water service. There is one water service for four different businesses in the Plaza. One of the tenants hasn't made a water payment since April of 2018. The owners of the Plaza asked Mayor if he can do something. They owe over \$35K and if it isn't paid, they will get taken to court. The water can't be shut off because it will turn off water to those other businesses in the Plaza. Mayor asked the Board if they had any input. Trustee Koske asked if, going forward, there is a way to split the water bill so this doesn't happen again. The Mayor agreed there should be a policy that each tenant has their own service. Trustee Jensen asked when the lease is up and Mayor said there are a few years left on the lease. Mayor said the Plaza owner wanted the Village to install a separate water meter for this tenant but he isn't sure that's something the Board will want to do. Trustee Stochl asked if the water bill is the responsibility of the land owner because that who has to ultimately pay for it. No matter how many meters all installed, the responsibility comes down to the land owner. Donovan said that Trustee Stochl is correct. Trustee Moore added the building where she resides has one meter and the bill is split amongst tenants and built into the Association fee.

Promote Fox Lake has asked for a donation. In past years, the Village has donated funds. Mayor said they are great for town with their mural and plantings. Trustee Koske asked if it's legal to give money to Promote Fox Lake since they are now a 501c3. Anne will find out if it's legal to give them a donation. In conclusion, Mayor Schmit said there will be no Village Board Meeting on Christmas Eve.

# 6. Village Administrator's Report

#### A. Liability Insurance Renewal Proposal

Anne Marrin talked about the Villages workers compensation and liability insurance. There will be a present a resolution at the net Village Board Meeting to be voted on. The overall renewal premium is \$438,468 which is 15% decrease from the current plan, saving the Village \$76,832. There is a line out for bids to make sure the Village gets the best pricing. Anne recommends the Board reviews the information and give feedback prior to the next Board Meeting on November 26<sup>th</sup>.

Anne said they are also in the process of reviewing health insurance and the tax levy.
