At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on December 14th, 2021, the meeting was called to order at 5:05 pm by Board Commissioner Kenney. The following official business was transacted:

IV. Approval of previous Meeting Minutes:

Commissioner Trinski made a motion to approve the minutes for 11/2/2021.
Commissioner Sadowski seconded the motion, all in favor.

V. Unfinished Business:

- a. Chief Lee updated the Commission on a candidate that graduated from the Academy, and reports that he in phase one of his FTO Training, and is doing well.
- b. The next Academy date will be with SLEA Police Academy begins March 28th, 2022 and runs through July 1st, 2022. There will be a POWER test on March 8th, 2022.
- c. The results from the exam for new patrol officer candidate applications have been reviewed, and an initial eligibility list will be forthcoming. The Commission requests that oral interviews be held on January 8th, 2022. Commissioner Trinski motioned to have failure and interview notices sent to the applicants, as well as to hold oral interviews on January 8th, 2021. Commissioner Kenney seconded, all were in favor.
- d. Chief Lee informed the Commission that a lateral hire, who used to work for the Village of Fox Lake, will be starting after the new year.

VI. New Business:

- a. Chief Lee requested that National Testing Network be used for our promotional examination process. Commissioner Trinski motioned to use NTN for promotional testing, Commissioner Kenney seconded it, all were in favor.
- b. Chief Lee requested that the Commission and the Police Department consider promotional testing policies and procedures be made more detailed within the Commission's Rules and Regulations. The Commission mentioned that a re-write of the Rules and Regulations, in relation to promotional testing may be necessary. Commissioner Kenney motioned to request re-writes of the Rules and Regulations from legal counsel, to which Commissioner Trinski seconded, and all were in favor.
