At the Board of Police and Fire Commission Meeting, held at the above address in Lake County Illinois on March 1st, 2022, the meeting was called to order at 5:13 pm by Board Commissioner Kenney. The following official business was transacted:

IV. Approval of previous Meeting Minutes:

V. Unfinished Business:

a. Chief Lee updated the commission on the status of a candidate background that had been completed. The candidate withdrew himself from further consideration.

Commissioner Kenney motioned to accept the candidate's withdrawal from our current eligibility list, Commissioner Sadowski seconded, all were in favor.

b. Chief Lee updated the commission on the status of a lateral hire Officer from CPD. He is currently in the FTO program and is doing well.

VI. New Business:

a. Chief Lee updated the Commission on the promotional testing requirements and cost. He also detailed the promotional testing process through National Testing Network that will be conducting the test. The promotional test will be held on May 26th, 2022, here at FLPD. A time will be determined at a later date.

b. Chief Lee also presented that at this time, we have most of the eligible Officers in accordance with the amended rules recently adopted by the Commission, interested in taking the promotional exam. There are a few Officers that have not

yet responded to the announcement, but Chief Lee is confident that all eligible Officers will request to take the exam.

- c. The Fox Lake Police Department has started an Awards and Commendations committee, to allow peers and supervisors to recognize and acknowledge both Civilian and Law Enforcement employees that provide outstanding service to the Village and the Community it serves. Chief Lee notified the Commission that there will be an awards ceremony in a week that will recognize the Officer of the Year and the Civilian Employee of the Year at the Village Board Meeting.
