**IV. Approval of previous Meeting Minutes:**

**V. Unfinished Business:**

- a. Chief Lee and Commander Martin updated the commission on the status of a candidate background that had been completed. The candidate successfully passed all background investigations and was recommended by Commander Martin to be hired as a patrol officer. Commissioner Trinski motioned to extend a conditional offer to the candidate, Commissioner Sadowski seconded, all were in favor.
- b. Chief Lee updated the commission on the status of a candidate currently in the Academy. She was injured during her first week in the academy, but has since recovered and is doing well.
- c. Chief Lee discussed with the Commission the promotional testing that is set to occur on May 26<sup>th</sup>, 2022 at 1pm. Testing materials have arrived and it was discussed how the exam is to be scored and what points are to be awarded. The Command staff assessed merit points based on candidate performance and have

been sealed for confidentiality, so as not to be known by the Commission until scoring is complete.

**VI. New Business:**

- a. Commissioner Trinski signed the Rules and Regulations governing the Police Commission.
- b. On May 31<sup>st</sup>, we will have 2 candidates taking the POWER test for entrance into the Suburban Law Enforcement Academy that starts on June 20<sup>th</sup>, 2022.
- c. In April, Commander Joe Martin successfully graduated top of his class at Staff and Command through Northwestern University.
