## 11. New Business (the information below taken from Agenda)

- A. Resolution 2022-R-63: A Resolution Authorizing the Mayor of the Village of Fox Lake to Sign and Thereby Accept the Proposal from Standard Equipment Company for Repair Services to the Street Sweeper It was thought that the village would have to replace it, but it is actually repairable.
- B. Resolution 2022-R-64: A Resolution Authorizing the Mayor of the Village of Fox Lake to Sign and Thereby Accept the Proposal from Superior Paving Inc. for Snow Plowing and Ice Control Services at all Metra Parking Lots Superior Paving has done the snow plowing and ice control services the past 3 years. They were also the only bidders at \$95 per hour.
- C. Resolution 2022-R-66: A Resolution to Accept Placement of a Professional Fellow from the Youth Southeast Asian Leadership Initiative Department of State Providing Purposeful Work, Cultural and Collaboration Opportunities

YSEALI professional fellows program is sponsored by the U.S. State Department, Bureau of Educational and Cultural Affairs (ECA), and aims to bring emerging leaders to the U.S. for fellowships designed to broaden professional experience. The Village of Fox Lake was approved to host a fellow this fall. The candidate is from Burma, her focus will be on an eco-tourism analysis for the Village and she will be here for 4 weeks.

D. Resolution 2022-R-67: A Resolution Authorizing Submittal of a DCEO Tourism Grant Application

The village is applying in the tourism attractions category specifically focusing on our Lakefront Park development and amenities that can be phased in to meet the grant requirements.

E. Resolution 2022-R-68: A Resolution Authorizing the Mayor of the Village of Fox Lake to Sign and Thereby Accept an Amended Intergovernmental Agreement with Lake County Stormwater Management Commission for the Knollwood Subdivision Flood Mitigation Project

This is just a change in language not in the plans.

F. Resolution 2022-R-70: A Resolution Approving the Third Amendment to Option and Lease Agreement for Cell Tower at 104 Honing Road, Fox Lake, Illinois

The Village is owner of property at this location and has leased a portion of the property for use of a cell tower. The tenant has requested to sublease space on the tower. The agreement would extend till 2029.

G. Ordinance 2022-50: An Ordinance Directing the Disposal of Surplus Property by Various Means

The Village has purchased equipment through the budget process to assist the police department personnel with providing services to the community. Some of this equipment is specific to services providers that are no longer used by the police department. This is mostly obsolete electronics, gas masks that are expired and other items no longer needed or in use.

H. Motion to Approve the Façade Improvement Program Grant Request for Property at 1280 S. Route 12

This item is for a new primary wall sign located above the new store front. The Village would match \$2,399.75 which is 50% of the total amount permitted by the Village Code.

I. Motion to Approve the Façade Improvement Program Grant Request for Property at 21 Rollins Road

This item is to add a ramp for accessibility; the Village would match \$4,000 of the total cost, which is the maximum grant amount permitted by the Village Code.
