### **BRUSH PICK UP**

Brush pick up will begin in the Spring weather permitting. Pick up will be every Friday through Fall. Branches must be from trimming done by the homeowner only, not a tree service. Please call the Street Department at 847-587-8570 to be placed on the list for pickup. Guidelines; all cut ends facing the street, no limbs longer than 6 feet in length, no limbs larger than 6" in diameter, stacked neatly at the curb. The village may not pick up piles that don't meet these standards.

### **BUILDINGS / PERMITS**

Buildings must be maintained in good repair and safe condition in accordance with the 2015 Property Maintenance Code. Building permits are required for; Roof replacement or repair, any interior or exterior structural changes, any electrical or plumbing changes, fences, signs, swimming pools, tree removal and driveways. Please contact Community Development if you are unsure a permit is required.

### **BURNING**

Burning of leaves must be 30' from any structure (Ref: Village Code 4-1-1-7) and is only allowed *between April 1 – June 1, and September 1 – December 1* or by special permit. (5-2-1)

### **DOGS**

Dog licenses are required and expire June 30<sup>th</sup> of each year. The cost per license is \$5.00. No more than two dogs are allowed per household.

### **GARAGE SALES**

Maximum three days in length, two permits per year. Fee: \$5.00 per sale. Hours 9:00 a.m. to sunset. Signs allowed, one on premise and two off premise. Cannot exceed 2.5 sq. ft.



### **GARBAGE AND REFUSE**

Garbage bills are on a bi-monthly basis, and may be included in on your sewer and water bill.

Village ordinances call for weekly pickup of 3 cans per household + one special item (no building materials included). Each home has one recycling bin.

Garbage receptacles cannot be placed curbside more than 24 hours prior to scheduled pickup, and must be removed within 24 hours after pickup. Cans should be placed out of view of a person facing the front of the premises. Cans should be no larger than 30 gallons and in good condition with tight fitting covers.

Apartment buildings (3 or more units) and businesses are responsible for arranging their own garbage pickup.

For special pickups (e.g. Furniture, carpeting, etc.) Call Waste Management at (800)796-9696. For a small extra fee they will pick up large household items in quantity as long as they are notified in advance.

### **PROPERTIES**

Grass must be cut on both occupied and vacant properties and maintained at a height of less than 8 inches. Grounds must be kept free of junk and debris at all times. Boats, RV's and trailers must be stored on a hard surface such as concrete, or asphalt. Rental units need to be registered and inspected.
